### INFORMATION

#### **on doping controls of CIPS international federations championships 2017**

***According to the CIPS Anti-doping Code and the WADA prescriptions, in the year 2017 the CIPS International Sport Fishing Federations have made the doping controls in the world championships: within the competitions and out of competition as well.***

#### **Fédération Internationale de la Pêche Sportive en eau douce (FIPSeD)**

In the year 2017 with regard to anti-doping controls, 28 tests have been carried out: 14 in competition, 14 during trainings. Here below the list of championships during which the tests were made:

All tests resulted negative, apart from:

- 1 positive case during the 37th Coarse Angling World Championship for Clubs, held in Saint Quentin (France), where a Portuguese angler resulted positive for Hydrochlorothiazide;
- 1 positive case during the 8<sup>th</sup> Feeder Fishing World Championship, held in Cabeçao (Portugal), where a Romanian angler resulted positive for Indapamide.

#### **Fédération Internationale de la Pêche Sportive en mer (FIPS-M)**

With regard to anti-doping controls, this year 8 tests have been carried out. Here below the list of championships during which the tests were made:

- 2 controls at the Big Game World Championship in Albufeira in Portugal (1 during the training and 1 during the competition)
- 2 Controls at World Championship Shore Angling for Masters in Spain (1 during the training and 1 during the competition)

- 4 Controls at the World Championships in Long Casting in France (3 for the Seniors and 1 for the Ladies)

All results received are negative: no positive reliefs on doping substances have been found.

### **Fédération Internationale de la Pêche Sportive - Mouche (FIPS-Mouche)**

In the Fly fishing championships 2016 again 4 Doping-Controls have been made,

In the year 2017 FIPS-Mouche continued in caring out the doping controls on its championships. In total there were carried out 4 anti-doping controls, all of them during the World championship in Slovakia (2 during and 2 out of the competition sessions).

We have received all 4 reports from the WADA representatives - one of them was positive, with prohibited substance of THC. Currently CIPS WADA commission rules on this issue.
