- member Federations and Associations are entitled to take part in the Congress by sending one delegate for each International Federation to which they belong;
- National Federations are asked to communicate the names of Delegates to the CIPS Secretariat at least **30 days prior** to the start of Congress;
- to be entitled to vote:
 - a) National Federations or Organisations must be up-to-date with payments of annual membership fees;
 - b) the delegate must possess a suitable proxy from his/her National Federation or Organisation;
 - c) if a member is unable to attend the Congress, he shall notify in writing the *Praesidium* thereof and may be represented by another Member. The latter, however, must hold a proxy for such a purpose. Members shall be allowed to represent only one more absent Member.
 - d) the filled in candidature form for the positions of President, Vice President and Treasurer to be submitted to the *Praesidium*, which will be sent with the agenda, shall be returned to the General Secretariat at least 40 days before the date of the Congress. Each candidature shall come with a written consent by the Federation of the candidate.
