**Decision of the CIPS Presidium  
16. April 2020**

The health of the sport fishermen is first and foremost our priority of our sport. Due to the seriousness of this health crisis caused by the pandemic made by the COVID-19 Corona virus, the Presidium of the Confédération Internationale de la Pêche Sportive decides to invite the Boards of the FIPS-ed and the FIPS-Mouche as statutory managers of their sport calendar for finalizing this calendar of the year 2020 until the middle of May 2020 – as the FIPS-Mer which has already postponed all championships of 2020 to 2021.

The Presidium requires all the three FIPS to make all necessary arrangements and to ensure the appropriate possibilities of the participation in 2021 for all national federations and athletes.

La santé des pêcheurs sportifs est avant tout la première priorité de notre sport. En raison de la grave crise sanitaire qui a été produite par la pandémie causée par le Coronavirus COVID-19 le Présidium de la Confédération Internationale de la Pêche Sportive décide d'inviter les Bureaux des FIPS-ed et FIPS-Mouche comme statutairement organisatrices de leur calendrier sportif à ce qu'elles mettent en définitive jusqu'à la moitié du mois de Mai 2020 leurs calendriers de l'année 2020 – pareillement à la FIPS-Mer laquelle a déjà reporté tous les championnats de 2020 pour l'année 2021.

Le Présidium demande à toutes les trois FIPS de prendre les dispositions nécessaires et également pour assurer les possibilités adéquates de la participation de toutes les fédérations membres, de tous les athlètes.

**Decision of the CIPS Presidium  
12.03.2020.**

The Presidium has taken the decision concerning the impacts of the pandemic made by the Coronavirus on the sport fishing.

***Decision of the CIPS Presidium***

The situation caused by the Coronavirus is becoming worldwide always more and more preoccupying. In this situation the CIPS Presidium – while aware of his responsibility to protect the health of all participants, athletes, accompanying people and, obviously, their families, has decided to postpone all international events – including the championships of the three disciplines: freshwaters, sea and fly fishing, and, of course, the 41st Congress in Acapulco as well – until, for the moment, the end of May 2020 but of course when competent international and national authorities will provide more reassuring information regarding the development of this dangerous epidemic which has already caused many deaths.

The CIPS Presidium will follow the development of the epidemic and in full knowledge of the information will make new decisions, in close cooperation with the FIPS Boards regarding the holding of the championships and the international events.
