- the meeting Agenda and any proposal received will be communicated by February the 19<sup>th</sup> 2024;
- member Federations and Associations are entitled to take part in the Congress by sending one Delegate for each International Federation to which they belong;
- National Federations must communicate the names of Delegates to the C.I.P.S. Secretariat at least **30 days prior** to the start of Congress;
- to be entitled to vote:
  - a) National Sports Federations or Organisations must be up-to-date with payments of annual membership fees;
  - b) the Delegate must possess a suitable proxy from his/her National Federation or Organisation;
  - c) if a member is unable to attend the Congress, he shall notify in writing the *Praesidium* thereof and may be represented by another Member. The latter, however, must hold a proxy for such a purpose. Members shall be allowed to represent only one more absent Member.
