Getting to the Congress Venue

TRAIN

Trains run to Slovenia from all neighbouring countries and numerous other European countries. Interchanges between the services of Slovenia's national rail operator and those of other European rail operators take place in the following cities:

· Villach · Graz · Zagreb · Trieste

The train station closest to your destination (the CIPS congress) is Bohinjska Bistrica, located on the Jesenice – Nova Gorica line.

BUS

Direct international bus services connect Bohinj, Slovenia, to the rest of Europe. You may also choose Bled as your final stop on an international bus route, from where public transport is available to the CIPS congress location in Ribčev Laz.

CAR

Slovenia has good connections to the rest of the European motorway network.

To use the motorways, you will need an e-vignette (digital toll sticker) to cover the length of your stay. This can be acquired online before arrival.

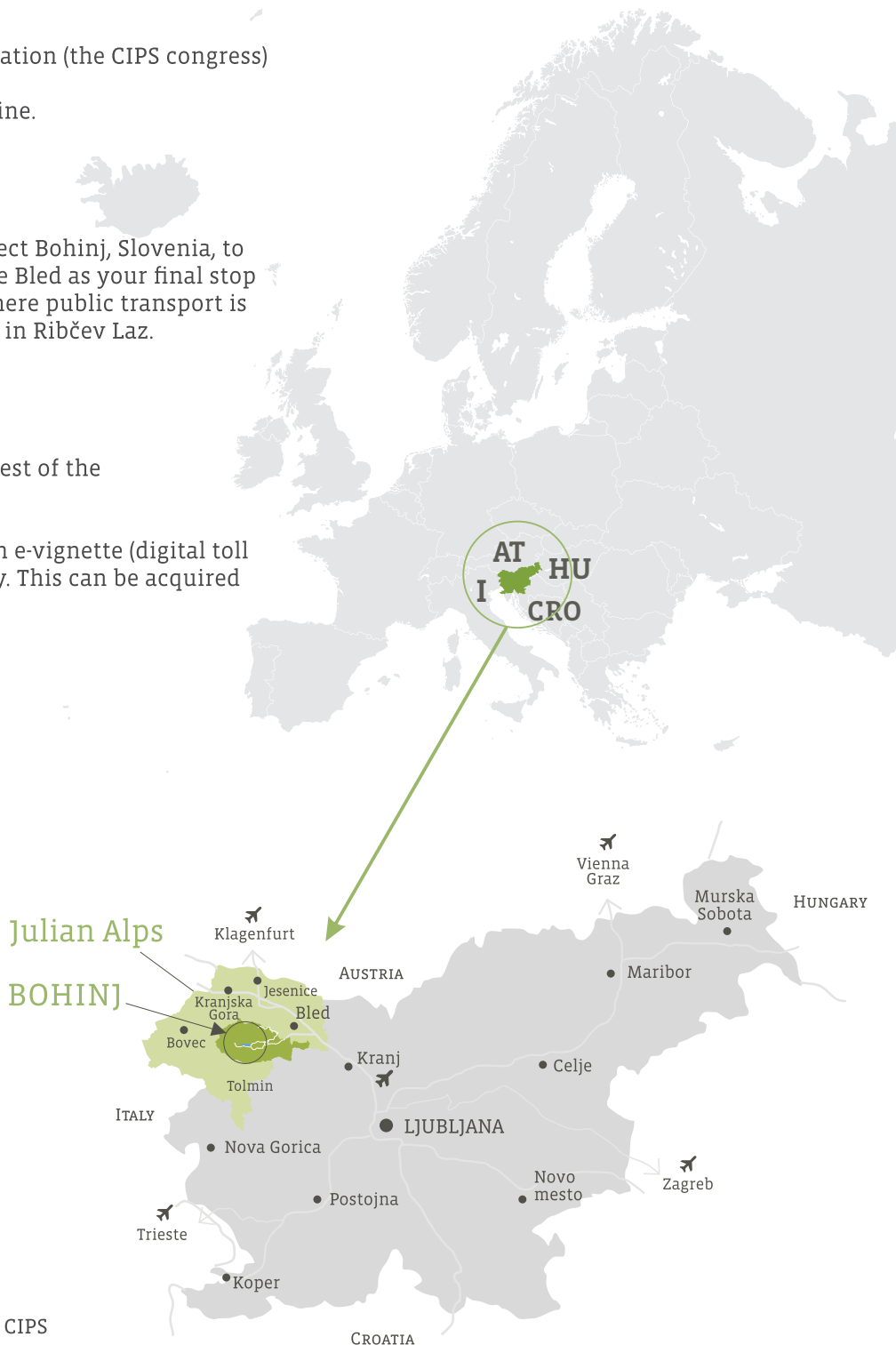

VISA REQUEST

Slovenian diplomatic missions and consular posts issue Schengen visas (A and C type visa) and national visas (D type visa). To obtain a visa, a third-country national must submit the required documents and meet the conditions prescribed by law.

The travel document must be valid for a period of at least three months after the intended departure from the country visited. It must have at least two free pages and must be recognised by the state conducting the visa procedure. Travel documents not recognised by all the Schengen countries are admissible but are subject to specific rules concerning the type of visa to be issued. 3. British citizens who are not nationals of the United Kingdom of Great Britain and Northern Ireland for the purposes of Union law:

British nationals (Overseas), British overseas territories citizens (BOTC), British overseas citizens (BOC), British protected persons (BPP), British subjects (BS).

4. Entities and territorial authorities not recognised as States by at least one Member State:
