Dear Sirs,

With reference to the convocation for the 47th Congress of the International Sport Fishing Confederation, to be held in Cairo, Egypt, from 23rd to 26th April, 2026, we hereby inform you that following the change of headquarters from Luxembourg to Spain of FIPS-Mer, certain statutory requirements and modifications are necessary, which will be approved at the extraordinary General Assembly of FIPS-Mer, to be held on 23rd April 2026. The modifications concern the entry of the International Federation in the Register of Sports Entities of the Spanish Higher Sports Council - section of international sports federations - replacing the entry of FIPS-M in the Luxembourg Trade and Companies Register - section of non-profit entities.

Following the above amendments of the Statutes, it is therefore necessary to add an item to the agenda of the CIPS Congress to introduce the ratification and approval of the new FIPS-M Statutes.

The new modified Agenda is attached.
